HOW TO APPLY

1. Complete the application

- Required information includes demographic information, program of study, pre-requisite information, and interest statement.
- You will be required to upload a resume so have that ready for when you process your application.
- Applications are due by February 20, 2025.

2. Complete the pre-assessment

- Complete the in-person proctored assessment on February 25 or 26, 2025.
- Score a 60% or higher on the assessment for priority placement in the program.
- Applications will not be considered without submission.

3. Submit Payment

- Applications will not be considered without a pre-assessment submission.
- > Accepted students must submit a payment of \$99 by March 14, 2025 to confirm their spot in the program.
